LABOR DAY WEEKEND SHOW

New Facility rules: MEC is under new management and will enforce the following policies.

1. Water is metered and must be used with care.
2. **Proof of rabies vaccination is required: no dogs will be allowed off leash.**
3. No dogs in the concession area, food service area or in bleachers
4. Park in designated areas only. All RVS or living quarters are subject to fees whether in the designated RV area or barn areas. A **charge of \$20 per night will be charged for “dry Camping”**. A **“fees paid”** sticker will be issued and must be visible in your window.
5. Advertisements/flyer postings-only allowed on the designated Blue Board located at main indoor arena
6. No entrance in designated areas marked “private”-please respect resident clients and horses
7. **No motorized vehicles, including children on motorized scooters & skate boards**, may be operated on grounds without current driver’s license

Important Show Rules & Information

1. APHA rules to apply
2. Amateurs and Novice Amateurs must present a current Amateur/Novice Amateur card at time of registration.
Remember the new APHA rule requires that all exhibitors must show proof of APHA membership –this applies to trainers also. All youth must be members of AJPFA in addition to having their youth cards.
3. The exhibitor must be able to prove ownership at the time of the show by presenting the APHA registration certificate or a **LEGIBLE** photocopy with the correct owner or owner’s name printed on the certificate by the APHA office. **THIS RULE WILL BE STRICTLY ENFORCED NO EXCEPTIONS.**
4. Management will strictly enforce the APHA rules of conduct. Unsportsmanlike or irresponsible conduct that is illegal, indecent, profane, intimidating, threatening, harassing, or abusive is prohibited as is the inhumane treatment of horses. Show management may immediately expel offenders from show grounds or show facilities.
5. **1st and 2nd Year Green is Open to any rider and can be any breed. A first Year Green horse cannot have been shown prior to Jan. 1, 2010. Second Year Green does not have to be consecutive.**

From Hwy 99 take Grant Line Rd. east to Jackson Hwy. Turn right on Jackson Hwy to Murieta Equine Complex (approx 6-7 miles)

From Hwy 50 take Sunrise Blvd South to Jackson Hwy. Turn left on Jackson Hwy to Murieta Equine Complex
