We have three TENTATIVE dates for next year at Watsonville Fairgrounds. May 20th, July 15th and Aug 26th. We still must confirm if these days are available.

Rule Changes for 2017: Open rule change: Exhibitor must show two of three shows in our circuit for the open yearend program. If we end up having only two shows, then the rule shall read: Exhibitor must show at one of our two shows of circuit to qualify for our Open yearend program.

For both the Open and the CCC programs, Jessica Tate made a motion to change the current meeting requirements from 2 per year to 4 per year. Denise Escover provided the second. Rachel Hodder made a motion to allow exhibitors to work extra hours to meet the meeting requirement. The value of the meeting shall equal 1 hour. There shall be a 2 hour max for missed meetings (Only 2 meetings can be worked off) Therefore, if you only attend 3 meetings you will need to work an extra hour to meet your yearend requirements. Hence, 3 meetings and 7 hours (6 hour requirement + 1 for missed meeting). Jessica Tate provided the second.

Diane wanted the exhibitors to be aware that we already have a hardship rule in place and wanted it brought up again for new members or members who may not have known of this provision in our rules. Jacqueline Price brought to the club the idea of putting out facebook blasts. She thought it would be good to allocate some funds or "budget" some money to advertise our shows. After much discussion, it was tabled until next meeting.
